



SECURITIES TRADING POLICY

Policy Owner: CEO

Policy Approver: Board of Directors

This Policy applies to trading in securities by all employees, contractors, consultants and other staff (Tyro Staff) and Directors (together, the Tyro Team) and their Closely Related Persons.

Introduction and Purpose

Purpose

The purpose of this Policy is to assist the Tyro Team to understand and comply with their obligations under the insider trading prohibitions of the Corporations Act and to protect the reputation of the Company, its Directors and each of the other members of the Tyro Team, by establishing best practice procedures for Dealing in Company Securities.

All members of the Tyro team should read this Policy carefully and familiarise themselves with the requirements and procedures detailed in it Tyro Team members must take reasonable steps to advise their Closely Connected Persons of this Policy and procure that they comply with this Policy as if they were Tyro Team members. If you have any questions about this Policy, please contact the Company Secretary.

Definitions

Capitalised terms used in this Policy are defined in the Schedule.

Key principles of insider trading prohibition

Conduct prohibited by law

Under the Corporations Act, if a person possesses "inside information" in relation to Securities of the Company or any other company, the person must not:

- Deal in those Securities; or
- Procure another person to Deal in those Securities; or
- directly or indirectly communicate the information, or cause the information to be communicated, to another person if the person knows, or ought reasonably to know, that the other person would, or would be likely to, Deal in those Securities in any way or Procure a third person to Deal in those Securities.

Importantly, given the broad definition of "Procure", a person who Deals in Securities through a trust or company while in possession of inside information may contravene the insider trading prohibitions and this Policy.

When a person possesses inside information

A person possesses inside information in relation to Securities of the Company or another company where:

- the person possesses information that is not generally available and, if the information were generally available, a reasonable person would expect it to have a material effect on the price or value of the Securities; and
- the person knows, or ought reasonably to know, that the information is not generally available and, if it were generally available, a reasonable person would expect it to have a material effect on the price or value of the Securities

Tyro Team members must assume that information is generally available only if it has been announced to ASX.

A reasonable person would be taken to expect information to have a material effect on the price or value of Securities if the information would, or would be likely to, influence persons who commonly acquire Securities in deciding whether or not to acquire or dispose of the Securities.

A person does not need to be an "insider"

A person can possess inside information in respect of a company, even if they are not associated in any way with that company. It is irrelevant how the inside information was obtained.

Penalties

A person who Trades in Securities while they possess inside information or communicates that information in the circumstances described in the above paragraphs above may be liable for both significant civil and criminal penalties.

In addition, a breach of this Policy may lead to disciplinary action by the Company, including termination of employment with the Company.

Examples of inside information

The following items are examples of information which may be inside information in relation to the Company:

- a change in financial forecasts or expectations;
- a proposed dividend;
- changes in the Board of Directors or senior executives;
- pending ASX announcements;
- proposed changes in capital structure, including issues of securities, rights issues, the redemption of securities and capital reconstructions;
- giving or receiving a notice of intention to make a takeover offer;
- debt facilities and borrowings;
- mergers, demergers, acquisitions and divestments;
- significant changes in operations, strategy or proposed changes in the general character or nature of the business of the Company or its subsidiaries;
- liquidity and cash flow information;
- sales figures;
- major or material purchases or sales of assets;
- significant new contracts or customers;
- an entity proposing to buy, or a securityholder proposing to sell, a substantial number of Company Securities;
- industry issues that may have a material impact on the Company;
- significant litigation involving the Company;
- allegations of any breach of the law or other regulatory requirements by the Company; and
- decisions on significant issues affecting the Company by regulatory bodies in Australia or other relevant jurisdictions (such as the Australian Securities and Investments Commission or the Australian Competition and Consumer Commission).

This is not an exhaustive list.

Restrictions on trading

General principles

Tyro Team Members must comply with the following general principles in relation to Trading in Securities:

- Tyro Team Members must comply with the insider trading provisions of the Corporations Act at all times and must not Trade in Securities whilst in possession of inside information in respect of those in Securities; and
- Tyro Team Members must not derive personal advantage from information which is not generally available and which has been obtained by reason of their connection with the Company.

Short term Trading - all Tyro Team Members

Tyro Team Members must not engage in short term Trading of Company Securities.

The acquisition of Securities and subsequent resale within a 6 month period and the sale of Securities and subsequent repurchase within a 6 month period would be considered to be transactions of a short term nature.

Transactions related to the exercise or conversion of options or rights and the subsequent sale of any resultant Securities under the Company's employee incentive schemes are not considered to fall within this restriction on short term Trading.

Securities of other companies

Tyro Team Members must not Trade in Securities of another company whilst in possession of inside information in respect of that company.

No Trading in Company Securities during Prohibited Periods

Tyro Team Members must not Trade in Company Securities during the following Prohibited Periods:

- from the Company's year end until the business day after the release of the full year results;
- from the Company's half year end until the business day after the release of the half yearly results; and
- any additional periods imposed by the Board from time to time (for example when the Company is considering matters which are subject to Listing Rule 3.1A).

However, even if a Prohibited Period is not operating, Tyro Team Members must not Trade in Company Securities at that time if they are in possession of inside information.

Prior written approval for Trading (Directors and Restricted Employees)

Unless otherwise specified in this Policy, Directors and Restricted Employees must seek prior written approval before undertaking any Trading in Company Securities.

This requirement applies to all Trading outside of a Prohibited Period and any Trading during a Prohibited Period which is subject to an exception set out in the section entitled "Permitted Dealings". The procedures for seeking prior written approval to Trade during a Prohibited Period as a consequence of Exceptional Circumstances are set out in the section entitled "Prior written approval to Trade during a Prohibited Period".

In order to seek approval to Trade, Directors and Restricted Employees must submit a written request, which may include an email communication, to the Designated Officer and copied to the Company Secretary. Such written request must include a declaration that the Director or Restricted Employee seeking approval does not have inside information relevant to the Securities or proposed Trade, and they are not aware of any reason why approval should not be provided. The Designated Officer may request such information as considered appropriate in the circumstances. The Designated Officer's discretion will be exercised with caution having regard to the importance of minimising both the risk, and the appearance, of insider trading. Directors and Restricted Employees should be aware that the Designated Officer may not provide the approval to Trade, without giving any reasons.

Directors and Restricted Employees may only engage in the proposed Trading if prior written approval is given by the Designated Officer. Any approval for the Trading will be valid for 7 days from the date it is given.

The Company Secretary will inform the Board of the details of all Trades approved.

Approval to Trade can be withdrawn if new information comes to light or if there is a change in circumstances.

The Company's decision to refuse approval is final and binding on the person seeking the approval and if approval to Trade is refused, the person seeking the approval must keep that information confidential and not disclose it to anyone.

Subsequent notification of all Trading (Directors and Restricted Employees)

Directors and Restricted Employees must provide the Company Secretary with subsequent written notification of all Trading in Company Securities within two business days, regardless of whether prior written approval has been given for that Trading.

Directors must provide sufficient details of all Trading to enable the Company to file a notice in accordance with the ASX Listing Rules within 5 business days of the Trade. The Company will also be obliged to notify the ASX whether the Trading by a Director occurred during a Closed Period where prior written approval was required and, if so, whether prior written approval was provided.

The Company Secretary will inform the Board of the details for all Trading notified to ASX.

Margin loans and other security interests

No Director or Restricted Employee may enter into a margin loan or similar funding arrangement to acquire any Company Securities, (which includes transferring Securities into an existing margin loan account, or selling Securities to satisfy a call pursuant to a margin loan) or grant lenders any rights over their Company Securities without first obtaining prior written approval.

In order to obtain approval to enter into a margin loan or similar funding arrangement, Directors and Restricted Employees must submit a written request to the Designated Officer and copied to the Company Secretary. Such written request must include information that the Director or Restricted Employee seeking approval does not have inside information relevant to the Securities or proposed Trade, and they are not aware of any reason why approval should not be provided. The Designated Officer may request such information as considered appropriate in the circumstances. The Designated Officer's discretion will be exercised with caution and having regard to the importance of minimising both the risk, and appearance of, insider trading. Directors and Restricted Employees should be aware that the Designated Officer is not obliged to provide the approval to enter into the relevant arrangement.

The Company Secretary will inform the Board at its next meeting of the details for all margin loan or similar funding arrangements entered into with approval.

The Directors and Restricted Employees must inform the Company Secretary of any material change in their margin loan or similar funding arrangements e.g. movements in the LVR occasioned by drawdowns or price movements, and at least annually, of the amount drawn and Securities covered.

Directors and Restricted Employees are reminded they must seek prior written approval in accordance with the section entitled "Prior written approval for Trading (Directors and Restricted Employees)" of this Policy before undertaking any Trading in Company Securities.

Approval to enter into a margin loan or similar funding arrangement can be withdrawn if new information comes to light or there is a change in circumstances.

The Company's decision to refuse approval is final and binding on the person seeking the approval and if approval to enter into a margin loan or similar funding arrangement is refused, the person seeking the approval must keep that information confidential and not disclose it to anyone.

Hedging and Derivatives

Tyro Team Members must not use, or allow to be used, any Derivatives or other products which operate to limit the economic risk of holding unvested Company Securities or Company Securities subject to a holding lock.

Trading during a Prohibited Period may be permitted in Exceptional Circumstances

A Director or employee who is not in possession of inside information in relation to the Company may Trade in Company Securities during a Prohibited Period if:

- the Designated Officer determines that an Exceptional Circumstance applies to the Director or employee;
- and

- prior written approval is granted by the Designated Officer in accordance with this Policy to permit the Director or employee to Trade in Company Securities during the Prohibited Period.

A Director or employee seeking approval to Trade during a Prohibited Period must satisfy the Designated Officer that Exceptional Circumstances exist and that the proposal to Trade in Company Securities during a Prohibited Period is the only reasonable course of action available. Tyro Team Members must apply for approval in accordance with the section entitled "Prior written approval to Trade during a Prohibited Period".

However, even if prior written approval is given, Tyro Team Members must not Trade in Company Securities if the person is in possession of any inside information.

Prior written approval to Trade during a Prohibited Period

In order to seek prior written approval to Trade during a Prohibited Period due to Exceptional Circumstances, Tyro Team Members must submit a written request to the Designated Officer. Such written request must include a declaration that the Director or employee seeking approval does not have inside information relevant to the Securities or proposed Trade, and they are not aware of any reason why approval should not be provided. The Designated Officer may request such information as considered appropriate in the circumstances.

The Designated Officer's discretion will be exercised with caution and having regard to the importance of minimising both the risk, and appearance, of insider trading. Tyro Team Members should be aware that the Designated Officer may not provide the approval to Trade, even if Exceptional Circumstances exist, without giving any reasons.

Tyro Team Members may only engage in the proposed Trading if written approval is given. Any prior written approval given for Exceptional Circumstances trading will be valid for 7 days from the date it is given.

Approval to Trade can be withdrawn if new information comes to light or there is a change in circumstances.

The Company's decision to refuse approval is final and binding on the person seeking the approval and if approval to Trade is refused, the person seeking the approval must keep that information confidential and not disclose it to anyone.

Permitted Dealings

Notwithstanding other provisions of this Policy, Tyro Team Members may Trade in Company Securities in the circumstances described below, **provided that the Director or employee does not contravene the insider trading prohibitions in the Corporations Act**. Please note that, unless otherwise specified below, the Policy requirements with respect to prior written approval and subsequent notification continue to apply to Trading under one of these exceptions – see sections entitled "Prior written approval for Trading (Directors and Restricted Employees)" and "Subsequent notification of all Trading (Directors and Restricted Employees)".

- No change in beneficial ownership - Trades in Company Securities where the Trading does not result in a change of beneficial interest in the Securities.
- Transfers into a superannuation fund - Transfers of Company Securities already held into a superannuation fund or other saving scheme in which the Director or employee is a beneficiary.
- Investment in fund - An investment in, or Trading in units of, a fund or other scheme (other than a scheme only investing in Company Securities) where the assets of the fund or other scheme are invested at the discretion of a third party.
- Director or employee acting as trustee - Where the Director or employee is a trustee or a director of a corporate trustee, Trading in Company Securities by that trust provided the Director or employee is not a beneficiary of the trust and any decision to Trade during a Prohibited Period is taken by the other trustees or directors or by the investment managers independently of the Director or employee.
- Accepting a takeover offer - Undertakings to accept, or the acceptance of, a takeover offer, or participation in a scheme of arrangement.
- Rights issue, security purchase plan, distribution reinvestment plan - Trading under an offer or invitation made

to all or most of the Company's security holders, such as a rights issue, a security purchase plan, a dividend or distribution reinvestment plan and an equal access buy-back, where the plan that determines the timing and structure of the offer has been approved by the Board, (this extends to decisions relating to whether or not to take up the entitlements and the sale of entitlements required to provide for the take up of the balance of entitlements under a renounceable pro rata issue).

- Participation in an equity plan – The participation in an employee or Director equity plan operated by the Company, including the acceptance of any grant or offer under such an equity plan and the associated application for or acquisition of Securities under the equity plan (and the Policy requirements with respect to prior written approval and subsequent notification do not apply to Trading arising from such participation). Where Securities cease to be held under the terms of the equity plan, any dealings in those Securities must only occur in accordance with this Policy.
- Exercise or conversion of options or rights - The exercise or conversion (but not the sale of Securities following exercise or conversion) of an option or a right. A Restricted Employee is not required to seek prior approval or notify the Company Secretary of the exercise or conversion of Tyro options or rights.
- Involuntary disposals caused by margin lender - An involuntary disposal of Securities that results from a margin lender or similar financier exercising its rights under a margin loan or similar funding arrangement, entered into with prior approval under this Policy.
- Share qualifications - The acquisition of shares by a Director of shares to obtain a share qualification.

Other matters

Cautions to consider

Under insider trading laws, a person who possesses inside information about an entity's securities is generally prohibited from trading in those securities and that this applies even where:

- the trading occurs at a time that would otherwise be outside a Prohibited Period specified in this Policy;
- the trading falls within an exclusion in this Policy; or
- the person has been given approval under the Policy to Trade (whether in Exceptional Circumstances or otherwise).

Approval to Trade under this Policy is not an endorsement of the proposed Trade. The person doing the trading is individually responsible for their investment decisions and their compliance with insider trading laws.

Before a Director or employee Trades in Securities, they should consider carefully whether they are in possession of any inside information that might preclude them from trading at that time and, if they have any doubt on that score, they should not Trade.

If a Director or employee comes into possession of inside information after receiving approval to Trade, they must not Trade despite having received the approval.

Financial Sector (Shareholding) Act

As an ADI, the Company, and its Securities, are subject to the Financial Sector (Shareholding) Act, meaning that any shareholding 'stake' in the Company above 20% could attract penalties. Prospective and existing shareholders should consider this limit, and seek relevant advice, when deciding to purchase Securities.

Changes to Policy

If any material changes are made to this Policy, the Company will give the amended Policy to ASX for release to the market within 5 business days of the material change taking effect.

Amendments to the Policy which are likely to constitute a material change include:

- changes to the Closed Periods;

- changes with respect to Trading in Company Securities which is not subject to a Prohibited Period; and
- changes with respect to the Exceptional Circumstances in which Tyro Team Members may be permitted to Trade during a Prohibited Period (as set out in the sections entitled “Trading during a Prohibited Period may be permitted in Exceptional Circumstances” and “Prior written approval to Trade during a Prohibited Period”.

Adoption of Policy and annual Board review

This Policy was first adopted by the Board on 6 December 2019 (being the date of the Company's admission to the Official List of the ASX) and replaces any previous policy in this regard.

The Board will review this Policy annually. The Company Secretary will communicate any amendments to Tyro Team Members as appropriate.

Record keeping

The Board will ensure that records are made capturing the details of all applications by Tyro Team Members for approval under this Policy and the decisions made in relation to those applications.

Definitions

For the purposes of this Policy:

ASX means ASX Limited or the financial market it operates (as the context requires);

ASX Listing Rules means the listing rules of ASX;

Board means the board of directors of the Company;

CEO means the Chief Executive Officer of the Company;

Chair means the Chair of the Board from time to time;

Closed Period means the periods set out in the section entitled "No Trading in Company Securities during Prohibited Periods";

Closely Connected Persons means:

- a. any spouse, de facto partner of, or any children residing with, a Director or employee; and
- b. companies, trusts, self-managed or other super funds and entities which are controlled by a Director or employee of individual referred to in paragraph (a) above;

Company means Tyro Payments Limited (ACN 103 575 042);

Company Securities means Securities issued by the Company;

Corporations Act means the Corporations Act 2001 (Cth);

to **Deal in Securities** means to apply for, acquire or dispose of Securities, or enter into an agreement to do any of those things, and Dealing has a corresponding meaning;

Derivative has the meaning in section 761D of the Corporations Act and includes options, forward contracts, futures, warrants, cash settled swaps, caps and collars;

Designated Officer means:

- a. in respect of a Director or the CEO, the Chair;
- b. in respect of the Chair, the Chair of the Board Audit Committee;
- c. in respect of a Restricted Employee (other than the CEO or Company Secretary), the CEO or Company Secretary;
- d. in respect of the Company Secretary, the CEO; and
- e. in respect of any other employee, the CEO or Company Secretary,

or such other person appointed by the Board as a Designated Officer for the purposes of this Policy;

Directors means the Company directors;

Exceptional Circumstances means, in relation to a Director or employee:

- a. (Severe financial hardship): a pressing financial commitment that can only be satisfied by selling the relevant Company Securities;
- b. (Tax liability): a tax liability of such a person would not normally constitute severe financial hardship unless the person has no other means of satisfying the liability. A tax liability relating to Securities received under an employee incentive scheme would also not normally constitute severe financial hardship or otherwise be considered an exceptional circumstance for the purpose of obtaining proper written approval to sell or otherwise dispose of Securities during a Prohibited Period;
- c. (Court order): a requirement to Trade in Company Securities as a result of:
 - I. a court order;
 - II. court enforceable undertakings (eg as part of a bona fide family settlement); or
 - III. some other overriding legal or regulatory requirement; or
- d. (Other circumstances): any other circumstances considered exceptional by the Designated Officer;

to **Procure** another person to Deal in Securities includes inciting, inducing or encouraging a person to Deal or not Deal in Securities;

Financial Sector (Shareholding) Act means *Financial Sector (Shareholding) Act 1998 (Cth)***Prohibited Period** means the periods set out the section entitled “No Trading in Company Securities during Prohibited Periods”;

Restricted Employees means:

- a. the CEO;
- b. the Chief Financial Officer;
- c. the Chief Risk Officer;
- d. the Company Secretary;
- e. the General Counsel;
- f. employees involved with preparing the Company's monthly financial reports;
- g. direct reports to the above positions; and
- h. employees nominated by the CEO or the Board as Restricted Employees (and who are notified accordingly);

Securities includes shares, options, rights, debentures (including convertible notes), interests in a managed investment scheme (including an option over an unissued unit or other interest in the scheme, and a renounceable or non-renounceable right to subscribe for a unit or other interest in the scheme), Derivatives, options over an unissued a share in, or debenture of, the Company, a renounceable or non-renounceable right to subscribe for a share in, or debenture of, the Company, and other financial products covered by s1042A of the Corporations Act; and

Trade means to Deal in Securities or Procure another person to Deal in Securities, and Trading has a corresponding meaning;

Tyro Staff means all employees, contractors, consultants and other staff of Tyro; and

Tyro Team means all Tyro Staff and Tyro Directors
